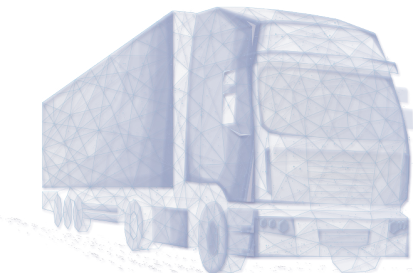

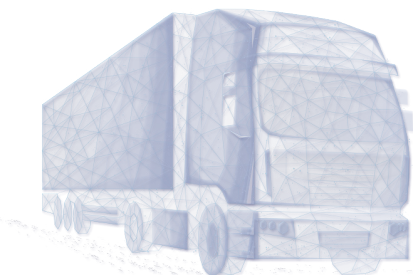

We are **NET 15 days** to pay from the DATE we RECEIVE the emailed invoice. Any carrier who chooses to mail invoices will be paid NET 15 from the DATE RECEIVED at our office.
